- Been apprehended or surrendered to law enforcement
- Hired an attorney and had the warrant reset/recalled or bond reinstated
- Done a walk through either with current surety, other bonding company or an attorney
- The defendant or indemnitor makes payment arrangements with the bonding company to satisfy the bond amount
- The bonding company recalls the assignment after contact has been made with the defendant, indemnitor or any other person related to the assignment
